KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have voluntarily associated ourselves together for the purpose of forming a corporation under the provisions of the general Nonprofit Corporation Laws of the State of California for purposes other than pecuniary profit, and we hereby certify:

I

That the name of this Corporation shall be TAMARACK SPRINGS MUTUAL WATER COMPANY, INC.

II

The purposes for which this Corporation is formed are:

- (a) To engage primarily in the business of a mutual, nonprofit water company in developing, distributing, supplying, and delivering water for domestic use to its members, at actual cost plus necessary expenses, upon and to certain real property situate, lying, and being in the County of Calaveras, State of California.
- (b) To acquire, hold, manage, use, and operate, in any lawful manner, a water plant and system, including pumping plants and reservoirs, water pipe lines, pumping equipment, and rights-of-way for water pipe lines, and the water system located on the hereinabove-described lands.
- (c) To engage in any business related or unrelated to that described in clauses (a) and (b) in this Article II and from time to time authorized or approved by the Board of Directors of this Corporation.

- (d) To act as partners or joint venturers or in any other legal capacity in any transaction.
- (e) To have and exercise all rights and powers from time to time granted to a corporation by law.

The above purpose clauses shall not be limited to reference to or inference from one another, but each such purpose clause shall be construed as a separate statement confirming independent purposes and powers upon the Corporation.

III

This Corporation is organized pursuant to the general Nonprofit Corporation Laws of the State of California and does not contemplate the distribution of gains, profits, or dividends to its members, its object being to furnish and supply water to its members only, at cost plus necessary expenses.

IV

The county in this state where the principal office of this Corporation is to be located for the transaction of business is the County of Calaveras, State of California.

The number of directors of this Corporation shall be such as may be fixed by the By-Laws or any amendment thereof. The names and addresses of the persons who are appointed to act as the first directors, until the selection of their successors, are:

real property. Water shall be sold, distributed, supplied, or delivered only to owners of the Corporation's shares, and such shares shall be appurtenant to certain lands when the same are described in the certificate issued therefor.
